16. If you were telling someone about Jesus which of these witnesses do you think you would talk about? If this is too general, think of a particular person, what stops them believing that Jesus is the Son of God?

17. What reasons does Jesus give in these verses as to why the Jews would not believe? (Many did believe, but most did not.)

## Pray

If you have thought about a particular person or people in question 16 pray for them and that God would be pleased to break down the barriers to their coming to faith.

Pray for our witness to Christ, for confidence in the gospel, and that the Holy Spirit would help us to have the right words at the right time.

Pray for those members of you Church who through age and infirmity are no longer able to get to church week by week. Pray for those who visit them regularly.

#### Sickness and sin

### Read John chapter 5 verses 1 to 14

1. We are not told why this man was invalided but what do you think Jesus means in verse 14?

Was Jesus saying that the man's suffering was the result of some particular sin all those years earlier, or more generally that sickness, suffering and death came into the world because of sin? (known as 'the fall', cf. Genesis 3).

2. What sign is there here that through Jesus the effects of the fall will eventually be undone?
